

‘121 Apprentice Interviews’ Terms and Conditions

By entering you are agreeing to these competition terms and conditions.

The interviews are being run by the Lift & Escalator Industry Association (LEIA) in partnership with Breckenridge The Growth Agency.

Breckenridge is LEIA’s digital marketing agency helping them to promote Careers in the Lift & Escalator Industry, specifically Apprenticeships.

Eligibility to enter

1. The interviews are open to Lift and Escalator Apprentices (electromechanic) working for LEIA members.
2. A maximum of one entry per individual is permitted.
3. You must have approval from your employer before submitting.
4. Entry submissions are free.
5. In entering, you confirm that you are eligible to do so and eligible to claim any prize you may win.

6. Entry submissions will be accepted from Monday 4th July, running to 5pm Wednesday 13th July 2022. Entries after this date and time will not qualify.
